Provisional Police Officer Certification Agreement

This agreement is meant to be legally binding upon those who sign it.

The Provisional Agreement Parties:

Rhode Island Police Officer’s Commission on Standards and Training-Chairman

Rhode Island Department of Public Safety-Municipal Police Training Academy- Executive Director

Sponsoring Law Enforcement Agency-Appointing Authority

Provisional Police Officer Candidate

1. The Executive Director of the Municipal Police Training Academy shall assign appropriate staff to review the Provisional Police Officer Candidate's credentials in accordance with Rhode Department of Public Safety-Municipal Police Training Academy General Orders 2.100 entitled, “Basic Recruit Officers Program Waiver” and General Order 2.102 entitled, “Provisional Police Officer Certification.”
2. The Sponsoring Law Enforcement Agency and the Provisional Police Officer Candidate shall be responsible to comply with any and all required conditions as stipulated in General orders 2.100 and 2.102.
3. It shall be the responsibility of the Sponsoring Law Enforcement Agency and the Provisional Police Officer Candidate to provide all information as required by the Provisional Certification Checklist.
4. The Sponsoring Law Enforcement Agency and the Provisional Police Officer Candidate must meet all conditions and stipulations as they apply to each party of this agreement to include, but not limited to, the successful completion of all required training programs.

5. The Provisional Police Officer Candidate shall successfully complete all required training within six (6) months of the commencing date of this agreement. Failure to successfully complete all required training within the six (6) month agreement period shall result in immediate revocation of the Rhode Island Police Officers Commission on Standards and Training Provisional Certification.
6. The Provisional Police Officer Candidate shall be subject to all Municipal Police Training Academy Rules and Regulations, Policies and Procedures during the duration of this agreement.
7. It shall be the responsibility of the Sponsoring Law Enforcement Agency to notify the Executive Director of the Municipal Police Training Academy immediately upon termination or suspension of the Provisional Police Officer Candidate's employment with the Sponsoring Law Enforcement Agency.
8. Termination or suspension of employment with the Sponsoring Law Enforcement Agency shall result in immediate revocation of the Rhode Island Police Officers Commission on Standards and Training Provisional Certificate.
9. Upon successful completion by the Sponsoring Law Enforcement Agency and the Provisional Police Officer Candidate of all training and conditions established and enumerated herein, the Rhode Island Police Officers Commission on Standards and Training shall issue a certificate of Basic Police Officer certification to the Provisional Police Officer Candidate.
