Rhode Island’s Ignition Interlock Program

This training is designed to instruct law enforcement officers on the ignition interlock laws in Rhode Island. Instructors include representatives from; Smart-Start Ignition Interlock Company, Division of Motor Vehicles, Attorney’s General Department and Department of Health.

In Rhode Island there are more than 250 interlocks ordered by the courts each year! Do your officers know:

- What an interlock looks like and where in the vehicle to find one?
- What is required of an operator when driving a vehicle equipped with one?
- What actions to take when you believe an operator is in violation of interlock law?

The goal of this training is to teach officers and supervisors what to look for when they stop a motor vehicle equipped with an ignition interlock as well as introducing them to the laws associated with the interlock program.

Topics to be covered include:

- Rhode Island’s hardship license
- Who is eligible for an interlock and what to do if a motorist tampers with the mechanism

Target Audience: Traffic officers, patrol level supervisors and officers who will need to know the law and legal procedures when confronting a motorist with an ignition interlock.
