Please Note: All Law Enforcement personnel assigned to work zones, are required to attend this training per federal and RI-DOT regulations. **DOT inspectors have been asking officers to verify that they have been "Work Zone" trained prior to being assigned to details at RIDOT construction sites as well federally funded work sites.**

The daily environment of a law enforcement officer can be extremely dangerous and Work Zones are part of that dangerous environment. Motor vehicle related incidences are still the number #1 killer of police officers each year. The Work Zone training program has been designed to improve safety for law enforcement officers in the Work Zone as well as:

- Understanding standards and guidelines related to temporary traffic control in the Work Zones.
- The role of law enforcement in the Work Zones.
- Recognizing the components of a typical Work Zone.
- Recognizing proper practices and procedures related to the use of law enforcement officers in Work Zones.
- Understanding the process required for 'construction' to take place on Rhode Island roadways.
- Use of flaggers on road jobs.
- Current federal and state regulations relating to Work Zones.

Please Note: Attendees are encouraged not to park personal vehicles in restricted areas – Park in North parking lots where there are plenty of great parking spots!
