The State of Rhode Island, Office of Internal Audit investigates DHS fraud, including SNAP (EBT), cash and other public assistance. EBT Trafficking is a nationwide fraudulent activity involving individuals who buy, sell or trade SNAP benefits for cash or other consideration. This training will provide in-depth understanding of how trafficking occurs, identifying and investigating these activities. If an individual is suspected or found guilty of SNAP fraud, individuals and SNAP retailers face legal repercussions such as disqualifications, fines, and/or criminal penalties.

#### Topics include:

- Understanding the role of the Office of Internal Audits, Fraud Detection and Prevention Unit.
- Develop skills in identifying the fraud schemes relating to EBT trafficking.
- Defining the differences between skimming, stolen EBT cards and trafficking.
- Learn how to identify the fraud schemes by knowing the right questions to ask the complainant.
- Understanding the different charges related to SNAP fraud based on the RI General Laws.
- Disclosure of SNAP recipient information.
- How to collaborate with other government agencies in joint prosecution.
- How EBT fraud in conjunction with additional charges can assist in prosecution.
- SNAP Disqualification Consent Agreement as past of a plea deal.

- Kimberly Seebeck, CFE, CWFI, Sr. Internal Audit Manager. Kim has worked in the judiciary system for 22 years and moved to the Office of Internal Audits in 2016 to manage the Fraud Unit.
